7.	Civil asset forfeiture is the process where law enforcement seizes the assets of suspected criminals. North Carolina state law prohibits state and local government from permanently keeping these assets unless the suspected criminal is actually convicted in a court of criminal law. However, law enforcement agencies within New Hanover County participate in the Equitable Sharing Program with US Department of Justice. As a result, local law enforcement will request that the federal government seize these assets permanently from a suspected criminal, and then the local law enforcement agency receives up to 80% of the asset's value in return. Participation in this program has resulted in many individual's losing substantial amounts of money, and other valuable assets, without ever being convicted of (or sometimes ever being charged with) a crime. 	Law enforcement officers have to put their safety first, and therefore should consider all criminal suspects as armed and dangerous. Any failure by the suspect to comply with the orders of the officer warrants escalation, and the use of lethal force.
	Law enforcement officers need to consider all criminal suspects as "innocent until proven guilty." Therefore, the officer must employ the least intrusive means of arresting the criminal suspect.
	Law enforcement officers need to be trained on how to deescalate encounters with criminal suspects.
	If law enforcement officers observe that a criminal suspect is reaching for a nearby object, they should assume that they are reaching for a firearm, and the officer is justified in the use of lethal force.
