Parent Rights

We have observed the sovereignty of parents being violated on many fronts. While the medical decisions relating to masking and vaccinations are the focus at this time, these will likely fade over time. What should be most concerning to parents is the infringement of these rights that have been written into school policy. The policies that remove the choice of parents or force them to ask the school for permission need to be removed or changed. Parents voices need to be heard.

Safety in Schools

Violence and bullying is on the rise in our schools. To address this, I would make the following recommendations: increase the number of School Resource Officers (SROs) and support volunteers; and hold students accountable for their actions. Multiple and consistent SROs would help to repair the damaged relationships between students and law enforcement. Additionally, community support volunteers such as firefighters or retired military members, could provide students with role models with whom they could confide. Secondly, we need to hold students accountable. Parental involvement in a conference after a suspension has occurred has shown that students are less likely to be repeat offenders.

Re-establishing trust in the school system

Over 1300 students have left our school system this year. This is due to the growing distrust of school administration. Over the course of the past two years, the district has been deceptive in their funding of various programs and the creation of central office positions for selected individuals. This was done by the current superintendent without board approval. Policies have been created and curriculum has been selected without regard to parent wishes. This administration, including both the sitting board members and the superintendent, needs to be held accountable. The current superintendent needs to be removed and replaced. Deception within the policies and practices needs to be revealed.
